**WHEREAS**

- (a) The SETTLOR is desirous of establishing a Fund for Public charitable objects and approached the party of the second parts to become Trustees to execute the funds for above charitable Trust.
- (b) The party of the second Parts on the request, agreed to act as The First Trustees of these presents, as testified by their parties to and executing these presents.

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-**

- (1) In order to effectuate the said desire the SETTLOR has handed over to the Trustees a sum of Rs. 50000/- (Fifty thousand only) to hold and stand possessed for the same (hereinafter for brevity's sake referred to as "Trust Fund" which expression shall also include cash and any other property and investment of any kind whatsoever into which the same or any part thereof might be converted, involved or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) upon the Trust and with and subject to the powers, provisions, agreements and declarations hereinafter declared and contained of and concerning the same.
- (2) The same of the Trust shall be "**MAHAVIR EDUCATIONAL FOUNDATION TRUST**"
- (3) The objects for which Trust Fund is established are educational and advancement of any other Charitable Objects of General Public Utility related to education and health care not involving the carrying on of any activity for profit and for such purposes.
  - (a) To establish, maintain and/or grant aid in cash and/or kind to Medical Colleges, Nursing Institutions, Senior Citizen, Health Care, Child Welfare Education Centers and/or such other similar charitable institutions in India for the benefit and use of the public general.

- (b) To establish, support acquire run and/or grant aid and other financial assistance to schools, colleges, libraries reading rooms, hostel, boarding houses, laboratories and other institutions of like nature at any place or places in the Indian Union for use of the students and the staff and also generally for the development and/or **advancement of education and diffusion of knowledge amongst the public in general.**
  - (c) To establish, maintain and/or run studentships, scholarships and render other kind of aid to individuals including supply of medicines, books, stipends, medals and other incentives to study, without any distinction caste, colour or creed.
  - (d) To grant aid, to promote, establish, support and/or maintain institution for the promotion of Science Literature, Music, Drama and Fine Arts, for the preservation of old historical monuments and for the research and other institution having similar objects for the benefit of the public in general.
  - (e) To grant relief during natural calamities, such as famine, earthquake, flood, fire pestilence and other occasion of calamities of similar nature and to give donations subscriptions or contributions to institutions, establishment or persons during such relief work.
  - (f) To render assistance and/or grant aid to other Public Charitable Trusts or institutions related to above said objects.
  - (g) To do any other act for the advancement of general public utility related to education not involving the carrying on of any activity for profit, without distinction of caste, colour or creed.
- (4) The Trustees shall cause true and accurate account, to be kept for all money received and spent regarding all matters in respect thereof, in course of management of Trust properties or in relation to the carrying out of the objects and purposes of the Trust, as well as of all assets, credits and effects of the Trust properties.
- (5) For the furtherance of the objects of the trust and in accordance with the provisions of the Income -Tax Act, for the investmet or use of Trust Fund

for the time being in force ,the Trustees will have the following powers:

- (a) To accept any donation, contribution, grant or subscription in cash or in kind from Firm ,Company, Institution, any person ,body or personal body of persons or Trust with or without conditions.
- (b) To apply the whole or part of the income of the Turst Fund or accumulation thereof whole or part of the Turst fund to any one or more of the object of the Trust as the Trustees may in their discretion from to time determine.
- (c) To convert and deal with the Trust property and /or to carry the investments for the time being.
- (d) To invest and keep invested the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loan to any company, bank, firm any other person, and to alter, vary or transpose such investments from time to time as the Trustees may, their discretion think fit for other of the same or of like or different.
- (e) To borrow or raise or secure payment of moneys and also to lend money either with or without security.
- (f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (g) To let out, demise any immovable properly comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (h) To open account in the name of the Trust, Trustees and/or Institution run/conducted by the Trust with a Bank or Banks to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Chairman of the Trustees. The chairman of the Trustees will be **Sri Vijay Shankar Shahi**.

- (13) The Trustees shall have the power and their uncontrolled discretion, instead of acting personally, to employ and pay an agent (including any Bank) to transact any business or to do any act whatsoever in relation to the Trust of these presents, including the receipt and payment of moneys without being liable for loss, and shall be entitled to be allowed and paid all charges and expenses incurred thereby.
- (14) The Trustees may delegate in writing all or any of his powers under these presents to his nominee, who will be entitled so long as such nomination remains in force, to exercise such power, in the same manner as the Trustee himself could do personally.
- (15) The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and on every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
- (16) It shall be lawful for the Trustees to settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand, or things, proper for such purpose without being responsible for any loss occasioned thereby.
- (17) It shall be lawful for the trustees to borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (18) It shall be lawful for the Trustees :
  - (a) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donation, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Departments, Public and Other Bodies Corporations, Companies or Persons, Scheme and Other

(19) The Trust shall maintain proper books of account and the account of the Trust shall be closed every year on 31<sup>th</sup> March.

(20) These Trust Funds shall be and remain irrevocable for all times.

(21) The office of the Trust shall be situated at **205, Shashi Complex, Exhibition Road, Patna** unless changed by the Trustees by two-third majority.

(22) It is expressly declared that no part of the Trust property or its income of Trust Fund shall be supplied for any purpose outside India or for any purpose which is not a public charitable purpose in law and all provisions hereof shall be construed accordingly.


